WORKERS CRGANIZING COMMITTEE for the purpose of a thorough organization of workers within the jurisdiction now granted, or as hereafter defined by decisions of Conventions of the American Federation of Labor and Congress of Industrial Organizations, and for a more perfect Federation of all Trades, Labor, and Industrial Unions affiliated with the American Federation of Iabor and Eongress of Industrial Organizations. And the Union being duly formed and affiliated is empowered and authorized to initials into its membership any person or persons in accordance with its own laws not in conflict with this Charlor and with the Constitution, laws, rules and regulations of the American Federation of Labor and Congress of Industrial Organizations in convention made and as revised and amended from time to time. .:/ind to conduct the affairs of said Union in furtherance of the best interests of the American Federation of Labor and Congress of Industrial Organizations and of labor in general. The integrity of the Union shall be maintained and preserved and its autonomy secured. Provided, That the said Union abides by the rights and limitations set forth herein, and conforms to *the Constitution, laws, rules and regulations of the* American Federation of Labor and Longress of Industrial Organizations and as revised and amended from time to time, and in default thereof, or any part, this Charler may be suspended or revoked according to the laws of this Federation. And should the Union herein chartered be dissolved, (either by its own act or by act of this Federation) suspended or forfeit this Wharter then the persons to whom this Charler is granted, or their successors, kind themselves to surrender the same with such other property as shall property belong to this Federation. The name and title of this Almon is the property of the American Federation of Labor and Congress of Industrial Organizations. Alfron dissolution, suspension or revocution of this Charlor the name and title of this Union shall revert to the American Federation of Labor and Congress of Industrial Organizations and the above named Union shall thereupon cease and desist from using the same for any purpose whalsoever. And further, in consideration of the due performance of the above, the American Federation of Labor and Congress of Industrial Organizations FARMWORKERS does hereby bind itself to support the said <u>UNITED</u> CEGANIZING COMMITTEE exercise of all els rights, privileges and autonomy as an affiliated Union of the American Federation of Labor and Congress of Industrial Organizations as provided and set forth in the Constitution, laws, rules and regulations of this Federation and as revised and amended from time to time.
